Key Purpose

The purpose of this role is to ensure that all aspects of the premises is cleaned and maintained to a high standard.

Main Responsibilities and duties include:

- Ensure that all specified areas are cleaned to the standard required and all daily, weekly and periodic tasks are carried out as required
- Ensure all cleaning equipment is kept clean and maintained in good, safe working order
- Ensure that all defects in cleaning equipment are reported to the manager on duty
- Provide an ongoing cleaning service to the entire premises dealing with spillages, flooding, regular toilet cleaning, litter or any cleaning problem
- Replenish toilet rolls, soaps, paper towels and any other requisites as required
- Ensure that adequate supplies of cleaning materials and light equipment are kept, and the equipment is kept in good condition, used and stored correctly
- Ensure that all relevant safety precautions, in particular, control of substances hazardous to health (COSHH) are adhered to, when using and storing chemicals and cleaning materials required
- Advise the manager on duty of any faulty equipment or safety hazards within the Clip n' Climb arena, soft play facility, sensory room or toilets
- Carry out weekly/monthly deep cleans within the kitchen area
- Undertake any other duties of a similar nature related to this post that may be required from time-to-time
